

PUBLIC NOTICE

THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (VARIOUS ROADS IN CENTRAL MILTON KEYNES - COVID-19) (TEMPORARY CLOSURES AND RESTRICTIONS) ORDER 2021

NOTICE IS HEREBY GIVEN that the Council of the Borough of Milton Keynes intends, in not less than seven days from the date of this Notice, to make the above Order under Section 14(1) of the Road Traffic Regulation Act 1984.

The Council is satisfied that by reason of the likelihood of danger to the public during the Coronavirus pandemic (Covid-19) that the following temporary measures be introduced to help provide a safe and controlled area outside the temporary vaccination facility in Central Milton Keynes (CMK) during the pandemic.

The effect of the Order will be to introduce the following temporary restrictions in Central Milton Keynes: -

ITEM	RESTRICTION	LOCATION
1	Road Closure	Saxon Gate (east side)
2	Road Closure	Avebury Boulevard (south side) between Saxon Gate and the main entrance to Saxon Court
3	Road Closure	South Row between Saxon Gate and South Eighth Street
4	Road Closure	South Row (south side) between South Eighth Street and South Ninth Street
5	Road Closure	Avebury Boulevard (south side) between South Eighth Street and the main entrance to Saxon Court
7	V1 permit parking for staff	South Eighth Street (west side)
8	V1 permit parking for staff	South Row (south side) between South Eighth Street and South Ninth Street

The following vehicles will be permitted access the above closures: -

EXEMPTIONS	ITEM
Visitors (by appointment only)	Items 1, 2 and 3
Staff working at the temporary Vaccination Centre	Items 1, 2, 3 and 4
Taxis picking up/dropping off visitors (by appointment only)	Items 1, 2 and 3
Community Transport Vehicles/Buses picking up/dropping visitors (by appointment only)	Items 1, 2 and 3
Visitors with a valid blue badge (by appointment only)	Item 5
Deliveries to the Vaccination Centre	Item 5
Emergency Service and Military vehicles on operational duties	Items 1, 2, 3, 4 and 5

The Order will also allow for the closure of South Eight Street and Redway CMK 05. However, these closures will only to be introduced if it is absolutely necessary. The Council will serve a further notice in advance of any closure and access will be maintained at all times for the residents of South Eighth Street.

The temporary Order will come into effect on **8th January 2021** and will remain in effect for a period of **18-months** and will only take effect at times when indicated by the appropriate traffic signs.

Any person committing a breach of the order will be liable upon prosecution to such fine as prescribed by the Road Traffic Regulation Act 1984.
