## P22/030- Application 22/00138/FUL- Conversion and upward extension of 500 Avebury Boulevard

The paper, as previously circulated, was noted.

The Chair proposed that the comments comparing this site with that opposite should be disregarded, and the application before the committee should be considered on its own merits.

After considerable discussion it was agreed that the Town Council should **OBJECT** to the application on a number of specific points, as follows:-

- The low level of car parking provision (19.4%).
- The need for a Service Delivery Plan to be conditioned if approved.
- The lack of active frontages on the Avebury Boulevard aspect, which contravenes CMKAP Policy G7.
- Seek assurances that the mix and size of units together with affordability requirements accord with MKCouncil's Housing Policy.
- An indication of the plans for community provision within the s106 allocation.

## P22/031 – Applications 22/00464/FUL & 22/00465/LBC- Installation of Extract and Refit 3-5 Silbury Arcade

The papers, as previously circulated, were noted.

- Councillors noted the submission objecting to the lack of detail regarding the impact on the roofline of the new extraction plant.
