The Clerk and Councillor Lightfoot had a successful meeting with Ms. Carmichael recently, at which terms of engagement were discussed and agreed in principle, subject to an agreement being drafted for the role, based upon the job specification.

Ms. Carmichael is to develop a scheme of work to move the current lacklustre social media presence forward and to enable an ongoing presence to be maintained.

(i) Trubys Garden Tea Room

Councillors agreed to fund the above group in distributing food packages in sum of £500. It was agreed that the charity be requested to advise after

the completion of the exercise how many packages were made available to residents of CMK.

(ii) MOTUS

After considerable discussion, it was agreed that the sum of £400 be made available to the dance group. This decision was reached following a vote in which 3 councillors voted in favour, 2 against, with 1 abstention.

The group to be requested to provide details of activities taking place within the parish.

23/048- Tall Buildings

The paper, as previously circulated, was noted.

It was agreed that the Clerk should write to Bucks Fire & Rescue Service highlighting the obvious challenges which could be faced as a result of the construction of very tall buildings.

Councillors were of the opinion that s106 monies resulting from development of tall buildings should, in part, be directed to Bucks Fire & Rescue Service in sufficient sums to enable the purchase and maintenance of ladders and other equipment required to specifically address the challenges these tall buildings could present.
