It was agreed that the Clerk seeks clarification from MKCCouncil whether affordable housing targets are being met in other parts of MK and whether these are under the LHA guidelines or 80% of market rates.

Councillors expressed the view that 20mph zones are more appropriate in residential areas, of which there are none of any size within CMK. As 30mph is standard for the boulevards through CMK it was not felt necessary to consider approaching MKCCouncil to consider including areas in CMK for consideration within the current proposals.

It was agreed that the Town Council's position should remain as stated within the Movement, Connectivity, walking, cycling and e-scooters in CMK paper of February 2022 and this should be reviewed as required.
