# P23/042 - Ratification of Minutes of the Planning Committee meeting held on 19<sup>th</sup> September 2023

After some discussion it was agreed that the NEUTRAL response previously agreed in respect of the previous submission on this site (22/01815/FUL) should be maintained.

However, there were a number of issues to be raised with the Case Officer which, it was generally felt, would enhance the site, as follows:-

- The area would benefit from improved public transport connectivity, and this could be achieved by a bus stop on Elder Gate.
- A plan of access routes to other parts of the city should be provided.
- Clarification of how coaches would access the front of the building should be provided.
- The addition of trees in the vicinity of the car parking spaces fronting the hotel access would enhance the appearance.

He noted that where schemes do not meet CMKAP policy on height this should be referenced in any Town Council response, albeit that its Planning Committee may choose to support a scheme due to its other considered merits, through what is technically termed *'planning balance'*.
