# <u>P23/067- Planning application 23/02561/FUL- Hard & Soft Landscaping, Xscape</u>

The papers, as previously circulated, were noted.

The following points were made:-

- The Chair observed that the land in question is privately owned by Xscape and not public highway, which had been assumed when the original application was considered.
- It was agreed that the objections lodged when the application was first submitted, in 2022, had been addressed by submissions within the new planning application.
- Concerns remained that mature trees were to be removed, albeit twice as many mature and middle-year trees were to be planted in their stead
- The proposals were not felt to add anything to the space.
- The sculpture within the area does not appear to be removed as part of the submitted plans.

After some discussion it was agreed that the Town Council would be NEUTRAL in respect of the application, but with the following comments being made:-

- The sculpture located within the red line should remain in its current location.
- There should be no overall loss of landscaping within the area.
