P24/015 – Apologies

All members of the committee were present. The Clerk noted the tabled amended agenda, which now included an additional item P24/022 which provided councillors with two minor applications for consideration at the meeting.

The Clerk called for nominations of the position of Chair. Councillor Thomas was proposed by Councillor Stabler and seconded by Councillor Murphy. As there were no further nominations, Councillor Thomas was formally elected Chair, and resumed chairing the meeting.
