P25/012- Planning application PLN/2025/0193- Refurbishment of Santander building including partial demolition and rebuilding

The papers, as previously circulated, were noted.

The decision of the Chair to engage DLP Planning Limited to provide a report on the proposal to guide its response was welcomed by the committee.

The Chair provided an overview of the report and provided a recommended response to the application. This proposal was broadly accepted by councillors, with amendments.

The Chair noted that, although DLP had commented regarding the provision of car parking in relation to MKC Council 2016 parking standards, recent changes in national planning policy do not require private parking provision in highly sustainable city centre locations unless there is a severe impact on the highway.

It was agreed that landscaping within the perimeter of the development should be consistent with the public realm.

After some further detailed discussion it was unanimously agreed that the application should be Supported, and that the response should incorporate the full text of the DLP report, together with points a) to d), with a further point e) relating to landscaping.

It was further agreed that the emphasis within point b) relating to disabled access should be enhanced by referring directly to and quoting sections 6.2 and 6.3 of the DLP report (without the 'if possible' reference) within the response.

Finally, point e) of the response was agreed to read 'We note that the development is to take place in phases, but that the car park is a long-term provision supporting the development. This should be designed and landscaped consistent with the standards of the surrounding public realm'.
